All were welcomed to the meeting and thanked for their attendance. The meeting was confirmed as quorate and was declared open at 1100.

The Chair acknowledged the attendance of John Devine from Muckle LLP, the Company's legal advisors.

1. Minutes of the AGM Meeting held on 15th October 2016

- The Chair confirmed that the minutes of the previous AGM had been made available on the website and hard copies were available at the meeting.
- The minutes were accepted as a true and accurate record of the meeting held on 15th October 2016.

2. Matter arising from the minutes

- No matters were raised.
- 3. To receive the Directors Report of the Activities of the Company during the year ended 31st March 2017 and to include a report from the Directors directly elected by the membership
 - Chris Jones (CJ) was invited to give a presentation of the Directors Report.
 - CJ commenced with a note of thanks to: The volunteers without whom the sport would not exist. Business Partners – Commercial and value in kind partnerships. London Inspiration Programme 2017 headed by Jane Stewart. Commonwealth Youth Games.
 - The presentation to the meeting covered the organisations performance for the financial year, detailing the key metrics and main achievements for the year, the priorities and challenges for the year ahead; and a review of the strategic plan, detailing the mission, vision and strategic priorities.
 - A copy of the presentation is available on the website and forms part of the minutes of the meeting.
 - Neil Costello (NC), a member elected director, gave a report detailing:
 - i. Elected Member representation on the Board
 - ii. Reflected on the positive changes in the Organisation since 2012.
 - iii. Acknowledgement of the reduction in funding from Sport England and spoke about how the organisation works in conjunction with Government policies to promote participation in our sport.
 - iv. Clarified the need for England Athletics to fund themselves as Sport England funding cannot be guaranteed in the future dependent upon Government priorities.
 - v. NC acknowledged that England Athletics should work hard to listen, consult and act upon the need of its members and this takes on many forms.
 - vi. Inclusivity is very important in our Strategic Plan and **NC** highlighted this specifically and acknowledged the need to make athletics accessible for all as 'good athletes make good clubs' and our Clubs are the basis of our sport.

4. To receive an address from the Chairman of the National Council

- Mike Neighbour (**MN**) thanked Tony Shiret for reinvigorating the National Council by making sure our Clubs views are represented by our Councils and key points are taking forward to the Board.
- **MN** advised he had been previously a Board member of the AAA and is the Chair of AFD.
- Encouraged feedback to be provided to the Councils by our Clubs and clarified that the Regional Councils are a great opportunity to promote and cascade the programmes of work provided by England Athletics.

5. To receive a presentation of the Company's Financial Statements for the year ended 31st March 2017

- Peter Crawshaw (**PC**) introduced himself as a Board Member and Chair of the Audit and Assurance Committee and is an active Official and Club member.
- **PC** presented a summary of the company's financial performance as detailed in the annual financial statement for the year ending 31st March 2017.
- Detailed the additional requirements of Sport England Governance Code (early adoption).
- Summary of the company's financial statement is available on the England Athletics website.
- 6. To appoint the Company's Auditors for the year ended 31st March 2018 and delegate agreement of the remuneration to the Board
 - **PC** proposed Haysmacintyre to be appointed as the Company's auditors for the year end 31st March 2018.
 - Seconded by Sally Hughes.
 - The decision was agreed unanimously and remuneration delegated to the Board.

7. To Elect a Member Elected Director

- The Chair clarified that one of the Board member elected Director positions term had been served and it was now incumbent on the membership to confirm their representative for the next term.
- John Devine from Muckle explained the process to re-elect which was by closed vote and in line with the current Articles.
- A break in the meeting for the votes to counted was taken at 1200-1205.
- Tim Soutar stood for re-election and Toks Adeniji stood for election.
- The Chair conveyed the results of the election and Tim Soutar was the elected Member Director.

8. Special Resolution – Amendment to Articles of Association

- John Devine (**JD**) from Muckle gave a background for the need of these amendments to the Articles of Association.
- **JD** took the published communication as read and invited questions relating to these changes.
- Alan Edwards clarified that the changes to the Articles regarding the National and Regional Council will need potential further changes as a consequence of the ongoing review, which was acknowledged.
- A show of hands was completed to show those in favour of the Amendment to the Articles of Association and this was agreed unanimously.
