

England Athletics Road Running Representative Opportunity

Corsa di Castelli, 20th October 2024

Introduction

The European Under 23 Road Race at the annual Corsa di Castelli provides high quality road competition for England best under 23 athletes. The selected 10k England Teams will compete against other international teams from across Europe and the race has a huge pedigree in supporting athletes to transition to higher levels of competition and build invaluable experience of competition overseas in a team context.

Please read this selection policy carefully including the additional notes BEFORE you complete the expression of interest form.

Eligibility Criteria

Eligibility To be considered for selection, athletes must satisfy the following:

- I. Be an England Athletics registered athlete and be eligible to compete for England (i.e. full British passport holder).
- II. Have achieved one of the stated qualification standards within the qualification period. Standards must have been achieved in a ratifiable UKA or World Athletics competition under standard race licensing and competition rules.
- III. Be eligible as an under 23 under World Athletics Rules as the competition. This requires athletes to be aged 23 or under on 31st December 2024.

Qualification Standards

14:35	5km or 5000m	17:00
30:30	10km or 10000m	35:00

^{*}Qualification performances must be achieved between 00:00 (GMT) 1st November 2023 & 23:59 (GMT) 25th August 2024.

Selection Process & Criteria

- I. The team will be selected week beginning 26th August 2024.
- II. Up to maximum of 4 men and 4 women athletes may be selected. 1 non travelling reserve athlete may also be selected for each team.
- III. In order to be considered for selection athletes must have achieve the specified selection standard within the selection window. Achieving the standard does not guarantee selection.
- IV. In order to be considered for selection athletes <u>must</u> complete an expression of interest form prior to the selection window closing (23:59 25th August).
- V. In addition to meeting the selection standard the selection panel will consider the following when making selections:
 - Current form from races between 1st March 2024 and 25th August 2024. Current form will be given extra consideration when selections are made. Current form can be demonstrated through

- performances at different race distances or on different surfaces to the highlighted selection standards provided the selection panel consider the performances relevant to the event.
- Relevant head-to-head results from races within the selection window.
- Relevant past England, British or International championship performances within the selection window.
- Consistency of performance. Consistency of performance is determined by the frequency athlete has met or exceeded the outlined selection standard or achieved performances of a similar standard within the selection window.
- Future potential to represent England or Great Britain at major championships.
- Injury status.

Appeals

There shall be no right of appeal to the selection of the England Team made by the Selection Panel. The provisions of the UK Athletics Selection and Nomination "Fast" Appeals Procedure" do not apply to the England team selections for this event.

Additional Notes

- England athletics will not provide financial assistance for domestic assembly for international races (e.g. travel to or parking at an airport) or meals at the airport. Athletes based oversees will be expected to pay their own travel back to the UK to join the team on departure dates. Flights, hotels and transfers will be covered for the selected team.
- England Athletics will provide competition kit to any athletes that haven't received such kit within the last 2 years.
- England Athletics reserve the right to deselect athletes who the selection panel or team management feel are not ready to compete in the final weeks before the event.
- Athletes who withdraw themselves for reasons other than illness or injury (DOCTORS NOTE TO BE PROVIDED) may also be liable to cover the costs of their flights or a change of name to the ticket where there is the option to substitute.
- In exceptional circumstances only, England Athletics reserve the right to select athletes without a current standard or athletes from outside the expressions of interest
